You will take one exam for each line of insurance you wish to carry. Life, Accident, & Sickness (LA&S) and Property & Casualty (P&C) lines are combined lines in Georgia, so you will take two exams if you wish to attain all of these lines of authority: Property, Casualty, Life, Accident. Specifically, you will need 40 hours of Georgia pre-licensing training before sitting for the Georgia P&C licensing exam. Georgia Property & Casualty Insurance Licensing & Exam Prep Agents 1) Resident Renewal and Reinstatement Process Resident licensees are required to renew their license prior to its expiration. A licensee that misses the renewal deadline may file a late renewal request, which includes a \$15 late fee in addition to the renewal fee, within 15 days of the license expiration date. complete 24 Credit Hours of Approved Continuing Education every 2 years to be eligible to Renew their License. At least 3 of the 24 credit hours must be approved for Ethics Training. Georgia Property Only agents/producers are required to take an approved 20-hour Property course and pass the Pearson VUE 12-GA-03 licensing exam. How to pass the Georgia Insurance Licensing Exam ... Amendments: Example - If an agent holds a Life license and they are now applying to add property, the fee is \$100.00 for the license and \$15.00 for the processing fee for a total of \$115.00. The expiration will be on the last day of your birth month, biennially, based on the anniversary of your original license year. This means that if you were licensed on an even-numbered year, your license will expire on the last day of your birth month in the next even-numbered year.
